Commercial Embalmer Membership

\$695

Applicant must be duly Licensed and own or operate a commercial embalming establishment. Where more than one member establishment is operated by the same ownership, dues shall be determined independently. Each establishment receives one (1) vote.

Vendor Associate Membership

\$595

Applicant must be a vendor or supplier company of goods and services. Vendor Associate Members have no voting rights. Additional contacts can be added for \$100.00 each.

Associate Membership

\$175

Suppliers, cemetery owners, registered apprentices, and surviving spouses or dependents who are not actively employed by an establishment member. This is an individual membership and receives no voting rights.

Individual Membership

\$195

Any licensed funeral director and/or embalmer whose establishment does not qualify for a Firm membership is eligible for membership in this category. Any licensed funeral director and/or embalmer <u>not employed</u> by a licensed funeral establishment and/or Firm member is also eligible for membership in this category.

If you are the FDIC, Owner, or Manager of a licensed funeral establishment, you are not eligible to join as an individual. You must apply for a Firm membership.

Individual (Employee) Membership

If you are an employee of a Firm member, you are eligible for this discounted rate.

DEDUCTIBILITY OF TFDA DUES
